Comparison of Chapter 7 and Chapter 13 Bankruptcy (Chart)

In order to accord the debtor complete relief, the Bankruptcy Code allows the debtor to convert a chapter 7 case to a case under chapter 11, 12, or 13 (6) as long as the debtor is eligible to be a debtor under the new

chapter.
